






Participants will have the opportunity to use m-learning devices in their teaching and learning, assess and select appropriate applications and teach using new pedagogical approaches. At the end of the course, participants would have prepared a ready-to-use m-learning project for immediate implementation in their respective countries. Participants will require at least a smartphone (tablet preferable) to apply for the course.

Scholarship

Full board and accommodation will be provided for the duration of the training. (Twin sharing)


